Secure elections, strong voter turnout are top priorities for county board member turned Clerk candidate

Will County Board member and County Clerk candidate Lauren Staley-Ferry is known in her community for her hard work and dedication at any task she puts her mind to.

She has applied that same mindset to her candidacy for County Clerk, laying out a broad and ambitious plan for the office ranging from streamlining day-to-day services to maximizing turnout for eligible voters and increasing election security.

Cybersecurity

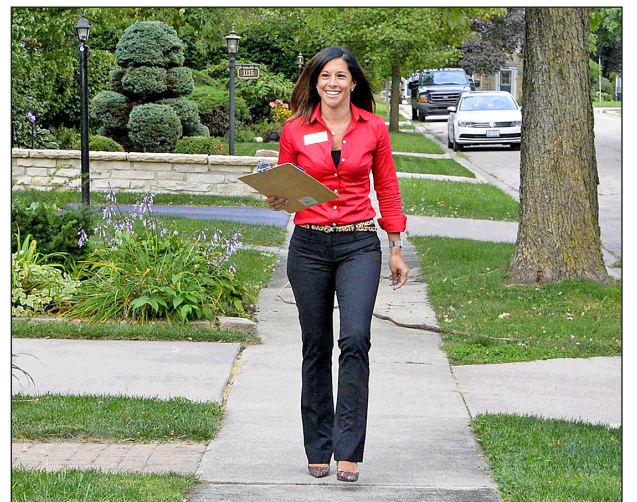
Staley-Ferry has a plan to collaborate with cybersecurity professionals, the

Will County State's Attorney's Office and fellow elected officials to ensure Will County's systems are

secure and that every vote is accurately counted and recorded.

"The sanctity of our elections is a bedrock of American democracy and we have to take that seriously at the local level. We are the first line of defense," Staley-Ferry said. "We have to get the greatest amount of people registered but we also have to give those voters confidence their vote will

Staley-Ferry: Working mom not career politician

Candidate has spent countless hours engaging community

A strong work ethic, down-to-Earth personality and an uncommon connection with constituents are all qualities that make Lauren-Staley-Ferry a strong pick to represent voters in the Will County Clerk's office.

"Voters can be sure I will address their concerns because our concerns are shared," Staley-Ferry said. "I am a working parent. I am not a polished career politician. My service in local government as a County Board member be-

gan four short years ago. But as a part-time elected official, I have applied all of my experiences as a working parent."

Because of this experience as a working parent, Staley-Ferry knows how hectic schedules can get, so she plans to increase opportunities for voters to cast their ballots at a time that is convenient to them. Her time on the county board and in the private sector give her a strong understanding of the process improvements that need to



be put in place to make this possible.

"In the private sector, my teams were entrusted with the direct management of

projects involving data protection and cyber security for literally hundreds of thousands of consumers, clients and employees,"

Staley-Ferry said. "I am uniquely prepared to deploy these same security strategies to protect the integrity of our elections

as the next Will County Clerk." Staley-Ferry's work at a Fortune 500 and National Top 10 institution gives her vital experience, but her engagement with voters sets her apart from others candidates.

"I understand the concerns of residents from

County board gave Staley-Ferry experience

Candidate has shown knack for bipartisanship, connecting with people

As a county board member, Lauren Staley-Ferry has taken a hard-working approach to staying involved in the communities she represents and beyond.

In four years, she has become a regular participant at community meetings such as the Cunningham Neighborhood Association and the Fairmont Community monthly meetings.

Staley-Ferry said meetings like these help her remain engaged with the people so she can best represent their interests.

Her track record on the county board is one of bipartisanship and working in the interest of Will County. In 2015, Lauren worked to protect vital

health department services that faced elimination due to the state budget crisis.

When state money for these important mental and physical health programs dried up, Lauren worked with leadership to fund them at a county level. As her district depended heavily upon the services of the Will County Health Department, she knew it was her duty to speak up on behalf of her constituents.

After the 2016 elections, Lauren was chosen as minority whip for the Democratic caucus in just her first term on the board. Lauren's colleagues, including Denise Winfrey who represents District 8, recognized her strong

organizational skills, work ethic and ability to reach across the aisle.

"Lauren Staley-Ferry has proven herself to be a quick study and eager worker in the effort to provide quality service to the residents of Will County," Winfrey said.

Lauren also serves on the Legislative, Finance and Executive Committees. She even attends most meetings of the committees on which she is not officially seated, ensuring she is engaged in all aspects of Will County business.

Staley-Ferry has made it a priority to also be active politically. She plans and attends events to help local Democratic Party candidates get elected. She organized the first Democratic Caucus Political Action Committee and coordinated the first caucus fundraiser, raising thousands of dollars to re-elect board

members and help new candidates run for office.

Lauren also meets with potential candidates and people interested in running for office to help them understand the responsibilities and time commitment that comes with running for the county board.

Because her various roles on the board have fostered an ability to reach across the aisle and engage

the community, Staley-Ferry believes she is perfectly suited for the Will County Clerk role.

"I was recruited into local politics because others recognized my work ethic and appreciated my dedication to our community," Staley-Ferry said. "I work hard every day to let the people of Will County know they made the right choice in me."

be counted without interference if we want our democracy to continue to thrive."

Staley-Ferry's diverse list of experiences – including work implementing security systems in the banking industry – make her the most qualified for the job of such monumental importance.

"My work in the banking industry has given me expert understanding of how to implement security systems to protect information provided by citizens, but there is no room to rest on prior successes," Staley-Ferry said. "Now more than ever we need a proactive County Clerk because not a day goes by without hackers trying to infiltrate systems of all shapes and sizes for nefarious purposes."

Voter Turnout

Staley-Ferry understands the importance of voter turnout in our democracy and plans to expand polling places and early voting hours to increase accessi-

bility and convenience for voters with busy schedules.

"Hectic schedules can make Election Day voting difficult. That is why we must add polling places, particularly in Eastern Will County where many people have complaints about a lack of access to the ballot box," Staley-Ferry said. "Early voting should enhance accessibility."

She also will seek feedback from constituents for increasing turnout in every election.

"I will work vigorously under the law to make it convenient to vote, no matter where you live in Will County," Staley-Ferry said. "We will also focus on engaging new voters. I will establish an outreach program that works with high schools and universities to encourage voter participation by young people."

Staley-Ferry said civics lessons at a young age are now more important than ever and she plans to focus on voter education efforts.

Streamlining Processes

With a diverse private-sector background,

Staley-Ferry knows how to eliminate waste and make processes more efficient. She plans to do just that as County Clerk.

"As a newcomer, I will bring a fresh perspective to running the Clerk's office that has literally been handed down from one clerk to a hand-picked successor of the same political party for 80 years," Staley-Ferry said. "In some cases, the way things have always been done might be best. But to adopt that philosophy across the board can cause stagnation and waste."

This means Staley-Ferry is prepared to examine ev-

ery line item in the office's nearly \$5 million budget to eliminate unnecessary expenses and redirect funding to where it best serves taxpayers.

"It is important to note that the County Clerk's staff has done a tremendous job over the years implementing policies and procedures they have been handed," Staley-Ferry said. "These talented and experienced employees, however, will have excellent ideas on ways to improve efficiencies and the delivery of services. I will seek their input and implement these new procedures in partnership with my staff."

Employee Specialization

Staley-Ferry also plans to use her private sector experience to implement a program to cross-train employees so the Clerk's Office will always be best positioned to serve the public.

"In the private sector, I initiated a program called 'Job Share' that involved the cross training of more than 100 coworkers. The benefits were many," she said. "We successfully prepared employees to cover for fellow workers in situations involving illnesses, extended leaves and vacations. We also found that our staff was revitalized and invigorated by these new responsibilities."

Staley-Ferry has ideas for a similar program within the Clerk's Office to identify employees who are content in their current roles, those who want to take on greater challenges, and those who might be seeking new roles.

"If our team is motivated and happy, we will provide better service to the public."

throughout Will County," Staley-Ferry said. "I have spent the past four years in local government reaching out, listening, and getting to know the people of Will County. I have visited with residents and made new friends from Naperville to Braidwood and from Channahon to Crete."

Staley-Ferry's goal in this outreach effort is to understand constituents' needs and the important issues in each community.

"As the Will County Clerk, I will continue to be engaged and accessible, and work hard to address the needs of the people," she said.

The outreach efforts are indicative of Staley-Ferry's work ethic, and they have helped her best represent her constituents on the Will County Board in the last four years.

"During my term on the County Board we have been successful in lowering tax rates and driving down expenses while implementing major building projects," she said. "The Will County Board has lowered the tax rate every year while I have served. At the same time, we funded the new Public Safety Complex that houses our Sheriff's Department and our new state-of-the-art 911 Center."

Will County is currently building a new courthouse which is tracking \$10 million under budget, and Will County's strong AA+ bond rating has yielded a \$30 million premium at last issuance.

At the same time, the Forest Preserve District has paid down bond debt, which will result in a significant tax bill reduction for residents. The district achieved this by reducing operating expenses.

"As County Clerk, I will take a similar approach, examining operations and finding ways to reallocate or reduce spending while improving and enhancing services," Staley-Ferry said.

To accomplish these goals, Staley-Ferry plans to put the same effort into the job that she has put in several other facets of her life.

"I have a strong work ethic. Any success I have experienced in the private sector or in government was accomplished through hard work and dedicated effort," she said. "Throughout my career, I worked long hours, applied myself vigorously, learned every new skill possible, sought direction from managers, and dedicated myself to professional and personal improvement. "My background demonstrates that I am prepared to confront professional challenges and to work tirelessly to provide the best services to our constituents."

Getting to know Lauren Staley-Ferry

Family life is driving force for candidate

For most of Lauren Staley-Ferry's life, Will County has been her home.

Born and raised in Joliet, Lauren was educated at St. Mary Nativity grade school, and she graduated from Joliet Catholic Academy in 1996.

In November 2008, she married her husband, Ed, and on New Year's Eve 2009, the couple happily welcomed their son Matthew to the world.

Since then, setting a good example for Matthew has been of utmost priority for Lauren and Ed.

While the family persevered together, things did not always come easy.

"We faced some difficulties due to the economy and the struggles of the construction industry," Staley-Ferry said. "But together we got through them."

After six weeks of Maternity leave in early 2010, Lauren returned to work at HSBC, the global financial services provider that had employed her since 2006.

"I supported my family because that's what was needed," she said.

Lauren's dedication to her family is mirrored by her dedication to anything she puts her mind to.

That showed in 2006, when she was hired to her position at HSBC. She didn't have any connections at the company to help her get her foot in the door, she simply applied for the job off the street and was hired.

After she got the job at

the global bank that was since acquired by Capital One, she put her mind to advancing the corporate ladder.

At Capital One, she worked in different areas of the business, including retail partnerships and third party management, and all of her 11 years at the company were spent in project management and process improvement.

"I managed teams from 30 to 100 people and found ways to improve processes while managing large-scale technology or compliance driven projects," Staley-Ferry said, noting the connections she made and the team-driven atmosphere have served her well in her public service career.

"In 11 years, I was always a top performer earning awards and numerous promotions," she said.

Staley-Ferry was seven years into her successful career at HSBC when she set a new goal – and a new example for Matthew: she

set her mind to obtaining her college degree.

"As I continued to grow in my career, I felt that I had reached a ceiling at Capital One for someone without a college education," she said.

In 2013, she enrolled at Rasmussen College.

For three years, she took on a full schedule of coursework while working full-time and taking care of a toddler. During that time she was also elected to the Will County Board in 2014.

In 2015, she reached her goal once again as she earned her bachelor's degree and graduated with honors.

While Staley-Ferry's main goal is still setting a good example for Matthew – who attends St. Raymond's School, plays soccer at Joliet Park District and plays baseball with the St. Joes Organization where he is coached by his father – she's added another goal to the list: serving her community as Will County Clerk.

In her own words: Q&A with Lauren

Q. Tell us a little about yourself?

A. I was born and raised in Will County (Joliet). I went to St. Mary Nativity Grade School and Joliet Catholic Academy High School ('96). I live in Joliet with my husband, a union electrician, and our 8-year-old son Matthew who loves soccer.

I am currently a member of the Will County Board where I represent a very diverse district that includes all of Crest Hill, and parts of Joliet, Lockport, Homer and New Lenox.

Q. Why did you decide to run for public office?

A. In 2013, I was approached about running for the Will County Board. I had never run for office before, so the thought was a bit intimidating.

While, I had been the outreach coordinator for Habitat for Humanity (Windy City Chapter at Capital One) and involved in other community organizations in Joliet, this seemed like an opportunity to serve my community and help make improvements in another way.

Therefore, I decided to run in the 2014 primary for Will County Board.

Q. What do you hope to accomplish as Will County Clerk?

A. I will enhance the security of our elections and protect our personal information. My work in the banking industry has given me expert understanding of how to implement security systems to protect information provided by citizens.

I will expand early voting hours and the number of polling places so that every citizen can exercise the most fundamental and important right in our democracy, and I will raise the level of voter participation throughout Will County.

I will systematically review all processes and procedures performed by the County Clerk's office to identify inefficiencies and waste. I will also implement a program to cross train employees so the Clerk's Office always will be best positioned to serve the public.

Q. There was an article in a local newspaper that referenced an incident from several years ago. Can you give us more information about that?

A. Nearly two decades ago, I made a mistake that I deeply regret. I take full responsibility for that. At the age of 23, I made a poor decision because I thought I had no option. I was in a bad relationship

and a desperate situation. From that experience, I learned that doing right by others is always the best option. It was a regrettable time in my life, but I refused to let it define who I am. My unwavering commitment to service, compassion, and integrity stemmed from that turning point in my life.

Q. Tell us why people should vote for you.

A. I am a working parent. I am not a polished career politician. My service in local government as a County Board Member began four short years ago.

But as a part-time elected official, I have applied all of my experiences as a working parent.

Like most of the people, I struggled with my family through the difficult economy. We live on a modest household budget. I know what it's like to send your child off to school and then rush to the office to be there on time.

I know when you walk into a government office that long lines and slow service can cost you valuable time away from your family and your job.

I know these things because I am a middle-class parent who is working hard to give my child everything I can. Voters can be sure I will address their concerns because our concerns are shared.

I am also experienced in data security, have held the line on taxes and expenses as a county board member, I have a strong work ethic and I understand the needs of the community.

Staley-Ferry's service goes beyond elected office

While Lauren Staley-Ferry was employed at global financial firm HSBC, a charitable effort opened her eyes to the possibilities and rewards of volunteerism and community service.

Lauren and her co-workers coordinated a program for the Make-A-Wish Foundation, providing funding to grant wishes for area families facing unthinkable medical burdens.

"It was then that I really discovered my passion for community service," Staley-Ferry said.

So she kept at it. In 2013, Lauren worked with a group of local women to organize the Wish Upon a Star Diamond Dash 5k race. Wish Upon a Star is a local charity that grants wishes for terminally ill children and their families in the Will County area.

After the successful

race, she joined the Executive Board for the Wish Upon a Star organization, and served until 2015. From 2014 until 2016, Lauren was the relationship lead for Capital One with Windy City Habitat for Humanity.

Since being elected to

the Will County Board in 2014, Lauren has taken an even more active role in the community. She attended the Joliet Region Chamber of Commerce's Community Leadership School, and she is a former member of Zonta International (Empowering Women through

Service and Advocacy).

Currently, Lauren serves as an Executive Board Member for Big Brothers and Big Sisters of Will and Grundy Counties. She is also a mentor in the Big Brothers and Big Sisters Mentor 2.0 program.

In addition to those ef-



orts, Lauren has served as a member of the Executive Board of the Spanish Community Center in Joliet since June 2017. The Spanish Community Center provides many different services to the local Latino Community.

Lauren sits on the Heri-

tage Corridor Convention and Visitors Bureau Executive Board promoting tourism along the Heritage Corridor and Route 66. The Bureau's efforts generate income for businesses and provide a stream of tax revenue that helps keep government services strong while helping to minimize the burden on the taxpayers.

Lauren further supports community organizations by regularly attending community and neighborhood events.

Whether it's a night out supporting a good cause or running a 5k race, Lauren has made giving back a priority.

"I have truly focused on helping the community every opportunity that I could. These experiences have been among the most fulfilling times of my life," she said.

On September 27, early voting begins at the Will County Clerk's Office and several other sites across Will County.

Requests for vote-by-mail ballots may be made online at thewillcountyclerk.com.

You may also mail in your request by using the printable form on the website.

The Clerk's office has begun mailing requested vote-by-mail ballots. They can be sent back starting September 27. It is the voter's responsibility to follow up if a ballot is not received.

October 9 is the last day to register in person or by mail and October 21 is the last day for online voter registration.
